## 1. AGREEMENT TO THE TERMS

#### 12. DISPUTE RESOLUTION

## **Binding Arbitration**

Any dispute arising out of or in connection with this contract, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration in accordance with the Arbitration Rules of the Mumbai Centre for International Arbitration, which, as a result of referring to it, is considered as the part of this clause. Arbitration proceedings shall be conducted in accordance with the following: (1) the arbitral tribunal shall consist of one arbitrator appointed by the Mumbai Centre for International Arbitration, (2) the place of arbitration shall be New Delhi, India, (3) the language of arbitration shall be English, (4) the award by the arbitral tribunal shall be substantiated in writing and the award shall be enforceable in any Court having jurisdiction, subject to Applicable Laws, and (5) the decisions of the arbitral tribunal shall be binding on the Parties.

#### Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceedings; (b) there is no right or authority for any dispute to be arbitrated on a class – action basis or to utilise class-action procedures; and (c) there is no right or authority for any dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

# **Exceptions to Arbitration**

The parties agree that the following Disputes are not subject to the above provisions concerning binding arbitration: (a) any Disputes seeking to enforce or protect, or concerning the validity of, any of the intellectual property rights of a Party; (b) any Dispute related to, or arising from, allegations of theft, piracy, invasion of privacy, or unauthorised use; and (c) any claim for injunctive relief. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a Court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.
